Congressional Update

Congress must act by January 19th to fund the Department of Transportation along with other agencies included in a separate group of agencies whose funding is set to expire on February 2nd.

The new funding patch would keep federal agencies running on two different timeframes. Funding for some federal agencies would expire March 1, while funding for others would run through March 8.

Speaker of the House Mike Johnson faces a possible revolt from the more conservative members of the House Freedom Caucus who oppose the spending levels agreed upon with Senate Majority Leader Chuck Schumer. The agreed upon levels mirror those that former Speaker Kevin McCarthy negotiated with Senate Democrats and the White House back in May of 2023.

Johnson, however, has reiterated his support for the agreement and plans to move the short-term CR to the floor where he will likely need Democratic votes for passage.

Senate and House Appropriators are still working to iron out agreements on funding levels for the individual spending bills and all agree this will take time well beyond the January 19th deadline. Regardless, the Federal Transit Administration has funding guaranteed under the IIJA to keep operations running even if Congress fails to act on the extension. The expectation is that Congress will pass an omnibus funding bill including congressional designated projects prior to the March deadlines.

FTA Procurement Tool

FTA's new <u>Procurement Cost and Price Analysis</u> - Regulations and Best Practices e-learning course is now available! The course provides recipients with an understanding of the fundamentals and best practices for procurement cost and price analysis. The lessons from this e-learning course can be helpful for FTA recipients in mitigating procurement findings during State Management and Triennial Reviews.

Tax Credits for Local Governments

IRS announced the launch of the IRS Energy Credits Online pre-filing registration tool for taxpayers who intend to receive a direct payment or transfer a clean energy credit. Established by the Inflation Reduction Act (IRA), Elective Pay (or "direct pay") and Transferability are credit monetization mechanisms to help states, local governments, non-profits, and other eligible entities access clean energy tax credits. Entities will use IRS Energy Credits Online to complete a required pre-filing registration process and receive a registration number. The registration number must be included on the taxpayer's annual return when making an elective payment or transfer election for a clean energy credit. DOT launched their <u>benefit cost analysis template</u> and <u>general guidance</u> (not new, just in a centralized location) to help grantees prepare their applications.

A list of <u>Data and Mapping Tools</u> that can be used for a strong discretionary grant application, including tools related to equity; safety; climate, sustainability, and air quality; and transportation analysis

Department of Labor Grant for Youth Apprenticeships

The U.S. Department of Labor released a <u>new funding opportunity</u> for YouthBuild. This funding opportunity is aligned to infrastructure workforce needs with a required focus on training young people in construction. This year, the funding opportunity has added a priority around Investing in America projects. Applicants who identify a project in their area that is funded through Investing in America and identify a partner that they can work with to prepare people for this project can receive extra funding. This means transportation agencies can help community partners in their area be more competitive by partnering with them and that workforce organizations and unions applying should seek to partner with a transportation agency. Note that unions are eligible to apply. This is a great opportunity for apprenticeship readiness programs to expand their training to disadvantaged youth and get funding for the supportive services necessary to be successful.

RAISE Grant

The U.S. Department of Transportation has published a Notice of Funding Opportunity (NOFO) for \$1.5 billion in grant funding through the <u>Rebuilding American Infrastructure with Sustainability and Equity</u> (RAISE) discretionary grant program for 2024. The popular program helps communities around the country carry out projects with significant local or regional impact.

Transit Vehicle Insurance

Transit agencies are finding it increasingly difficult to find, purchase, and maintain adequate and affordable insurance coverage for public transit vehicles. The number of smaller insurance providers is decreasing due to the volatile nature and demands of the insurance industry and insurance coverage requirements in general.

NCHRP Research Report 1079: Shared-Risk Insurance Pools for Transit Agencies: A Guide, from TRB's National Cooperative Highway Research Program, explains how insurance pools function, how to evaluate the feasibility of a shared-risk insurance pool, and how to establish and manage this type of pool.

Supplemental to report is a <u>presentation</u> and <u>NCHRP Web-Only Document 374: Developing a Guide to Shared-Risk Insurance Pools for Transit Agencies: Conduct of Research Report.</u>



DOT Charging and Fueling Infrastructure Program

The Charging and Fueling Infrastructure Program <u>awarded \$622.57 million in grant funding</u> to 47 applicants to strategically deploy publicly accessible electric vehicle charging and alternative fueling infrastructure in the places people live and work – urban and rural areas alike – in addition to a long designated Alternative Fuel Corridors (AFCs). The 47 awards are located across 22 States and Puerto Rico, and include 2 Tribes.

MPO Emissions Rule

The Federal Highway Administration recently issued a finalized performance measurement rule to provide state departments of transportation and Metropolitan Planning Organizations with a "national framework" for tracking transportation-related greenhouse gas emissions GHGs, along with the requirement to set their own targets for GHG reduction.

Summary

Our team coordinated for Connect to meet with State Senator Dave Koehler and State Representative Sharon Chung to discuss recent updates and priorities moving into the coming year. Following this meeting, we drafted a letter regarding Connect's proposal to establish a regional maintenance center for rural transit providers, in partnership with Heartland Community College. We worked with Connect's local legislators to gather their support for this project and sent the support letters from the members to IDOT Secretary Osman for consideration.

Additionally, our team continued to follow up weekly with House leadership and staff regarding the release of Connect's appropriation. We also spoke with Rep. Chung this week about the appropriation and she is going to also speak with House leadership on our behalf. With the start of the spring session on January 16th, we will continue to monitor for new bills or other activity which may impact Connect.

Short Description: STATEMENT OF ECONOMIC INTEREST

Amends the Illinois Governmental Ethics Act. Provides that all questions must be answered on the statement of economic interest. Provides that the Secretary of State shall neither accept a statement of economic interest for filing nor issue a receipt indicating that the statement has been filed unless the statement is verified, dated, and signed by the person making the statement and all questions on the statement are answered. Provides that the county clerk shall neither accept a statement of economic interest for filing nor issue a receipt indicating that a statement has been filed unless the statement is verified, dated, and signed by the person making the statement and all questions on the statement are

SB 1556

Short Description: EPA-CLEAN TRANSPORT STANDARD

Senate Sponsors Sen. David Koehler

Synopsis As Introduced

Amends the Environmental Protection Act. Provides that, to the extent allowed by federal law, the Environmental Protection Agency shall propose, within 12 months after the amendatory Act's effective date, and the Pollution Control Board shall adopt, within 12 months after receipt of the Agency's proposal, rules establishing a clean transportation standard to reduce carbon intensity from the on-road transportation sector by 20% by 2038, with further reductions to be implemented at the discretion of the Agency based upon advances in technology. Contains requirements for the Board rules and for the clean transportation standard. Exempts aviation fuels from the clean transportation standard. Provides that producers of sustainable aviation fuel shall be eligible to generate monetary credits on an opt-in basis that may be applied to future obligations or traded to providers not meeting the clean transportation standard. Requires the Agency to submit a report to the General Assembly detailing the implementation of the clean transportation standard, the reductions in greenhouse gas emissions that have been achieved through the clean transportation standard, and targets for future reductions in greenhouse gas emissions from the transportation sector. Contains other provisions. Effective immediately.

SB 2691

Short Description: EMPLOYEE SICK LEAVE-NOTICE

Senate Sponsors Sen. Laura Fine

Synopsis As Introduced

Amends the Employee Sick Leave Act. Provides that an employer may limit the use of personal sick leave benefits provided by the employer for absences due to an illness, injury, medical appointment, or personal care of the employee's covered family member to an amount not less than the personal sick

leave that would be earned or accrued during 9 months (rather than 6 months) at the employee's then current rate of entitlement. Provides that, for employers who base personal sick leave benefits on an employee's years of service instead of annual or monthly accrual, such employer may limit the amount of sick leave to be used under this Act to three-fourths of the employee's maximum annual grant (rather than half of the employee's maximum annual grant). Provides that an employer may not require an employee to provide advance notice of his or her use of personal sick leave benefits. Makes a corresponding change.

General Legislative Updates

103rd ILLINOIS GENERAL ASSEMBLY:

The Illinois General Assembly will begin the 2024 Spring Legislative Session on Tuesday, January 16. Both chambers are scheduled to be in session for three days next week. Key deadlines are quickly approaching. Note Friday, January 19 is the deadline to request legislation be drafted for consideration during the Spring Session. Friday, February 9 is the deadline to file legislation.

The Senate Assignments Committee assigned 129 Senate Bills to committees this week. All of the bills were originally filed during the 2023 legislative session. Below are highlights of key bills that were assigned:

- <u>SB 85</u> (Murphy) which creates the State Beverage Container Recycling Refunds Act was reassigned to the Senate Executive Committee.
- <u>SB 193 (Peters)</u> which creates the Illinois Rust Belt to Green Belt Pilot Program Act was reassigned to the Senate Energy and Public Utilities Committee.
- <u>SB 280</u> (Fowler) which creates the Department of Lottery and Gaming Act to consolidate the functions of the Department of the Lottery, the Illinois Racing Board, and the Illinois Gaming Board was reassigned to the Senate Executive Committee.
- <u>SB 1408</u> (Murphy) which provides that drugs prescribed to residents of the certain long term care facilities are not subject to prior approval as a result of the 4-prescription limit was reassigned to the Senate Appropriations Health and Human Services Committee.
- <u>SB 1413 (Rezin)</u> which creates the Sale of Pharmaceuticals on Social Media Act was assigned to the Senate Judiciary Committee.
- <u>SB 1549</u> (Rezin) creates the Wind Turbine Stewardship and Takeback Program Act was reassigned to the Senate Energy and Public Utilities Committee.
- <u>SB 1578</u> (Johnson) which provides that owners and operators of CCR surface impoundments at electric generating plants that are within 4,000 feet of Lake Michigan must close the CCR surface impoundment by removal and off-site disposal as specified in the legislation was reassigned to the Senate Energy and Public Utilities Committee.
- <u>SB 1656</u> (Castro) which creates the Internet Gaming Act was reassigned to the Senate Executive Committee.
- <u>SB 1823</u> (Villanueva) which addresses Environmental Justice communities was reassigned to the Senate State Government Committee.
- <u>SB 1908</u> (Villanueva) which creates the Warehouse Worker Protection Act was reassigned to the Senate Executive Committee.
- <u>SB 2421</u> (Fine) which creates the Carbon Dioxide Transport and Storage Protections Act was reassigned to the Senate Energy and Public Utilities Committee.

The Senate Judiciary Committee is the only Senate Committee scheduled to meet next week. The House Rules Committee has yet to assign bills to committees for hearings.

Representative Jonathan Carroll resigned this week. Carroll was not seeking re-election. Tracy Katz Muhl, who was the sole Democrat seeking the nomination to the 57th House District in the March primary, was selected as his replacement.

The behavioral health workforce shortage will be the topic of two upcoming hearings. On January 25 – and then again on February 23 – the House Mental Health and Addiction Committee will meet in tandem with the Senate Behavioral Mental Health Committee to address the subject. Both hearings will begin at 10 a.m. in the Bilandic Building in Chicago.

Local Republicans selected Brandun Schweizer to replace Representative Mike Marron in the 104th House District. Schwizer was already running as the sole Republican in the March primary.

The Illinois State Board of Elections ruled this week that Republican Representative Adam Niemerg is ineligible to remain on the March 19 primary election ballot because he failed to properly notarize his statement of candidacy. Niemerg can appeal the ruling in court or run as a write in candidate. He is the only candidate running for the seat in the 102nd House District.

State Senator Sue Rezin was named one of the co-chairs of the National Conference of State Legislatures' Natural Resources, Energy, and Environment Standing Committee. This committee seeks to protect states' interests in federal decisions on everything from agriculture to wastewater – including biotechnology, electric grid and transmission, fossil fuels, and nuclear and renewable energy. The committee provides legislators and legislative staff with an opportunity to share and learn from the experiences of other states.

GOVERNOR'S HIGHLIGHTS:

Governor Pritzker Celebrates Economic Milestones: The Governor joined the Department of Commerce and Economic Opportunity to celebrate the economic milestones reached during the Pritzker Administration. Read more here.

Grant Funding Awarded for Recreational Purposes: More than \$28 million in state grant funding has been awarded to local governments throughout Illinois for the construction, renovation, and improvement of buildings or land purchases for public recreational opportunities, Governor JB Pritzker announced today.

The funding comes from the <u>Park and Recreational Facility Construction Act</u>, or <u>PARC</u>, grant program, which is part of Governor Pritzker's bipartisan Rebuild Illinois capital improvement program. The Illinois Department of Natural Resources (IDNR) administers the program. A full list of recipients is <u>here</u>.

Cannabis Sales: The Illinois Department of Financial and Professional Regulation released key data for adult use cannabis sales for calendar year 2023. According to IDFPR, adult use cannabis sales set a new annual record in 2023, exceeding \$1.6 billion. Records were also set in sales to in-state residents and the number of items sold, with that total increasing more than 15% compared to 2022. Sales taxes collected at Illinois adult use cannabis dispensaries totaled \$417.6 million in 2023, per the Illinois Department of Revenue. Read more here.

Southern Illinois Healthcare Cancer Institute Awarded \$10 Million Grant: Southern Illinois Healthcare (SIH) Cancer Institute will receive a \$10 million grant for its recent expansion of the SIH Cancer Institute in Carterville. The grant is made possible through the bipartisan Rebuild Illinois plan to improve infrastructure statewide. The funding will help upgrade facility furniture, medical equipment, and the buildout of the Cancer Institute in Carterville. The Carterville plan, completed in December of 2022, included an approximate 20,000 square foot expansion and the modernization of both clinical and non-clinical areas.

Two additional state grants of \$150,000 each will help expand the SIH Cancer Institute Café, covering such costs as the design, oversight, and implementation of kitchen renovations.

Back to Business Local Chambers Program: The Illinois Department of Commerce and Economic Opportunity announced \$5 million is available in <u>grant funding</u> through the Back to Business (B2B) Local Chambers program. Following state recovery programming for businesses totaling \$1.5 billion, the latest American Rescue Plan Act (ARPA)-funded opportunity provides additional support for local chambers of commerce that experienced negative economic impacts from the COVID-19 pandemic. Read more here.

Environmental and Climate Justice Community Change Grant Program: Local governments, community-based nonprofit organizations, and higher ed institutions are being encouraged by the Illinois Environmental Protection Agency to address climate challenges and reduce pollution through a just-announced federal funding opportunity. The Environmental and Climate Justice Community Change Grant Program (Community Change Grants) -- created by the Inflation Reduction Act and administered by the U.S. Environmental Protection Agency (U.S. EPA) -- offers \$2 billion in grants in two tracks of funding.

Track I, Community-Driven Investments for Change, is expected to award approximately \$1.96 billion for 150 projects for \$10 million-\$20 million each. Under Track II, called Meaningful Engagement for Equitable Governance, some \$40 million will be available for 20 projects costing \$1 million-\$3 million each. Read more here.

Electric Charging Station Grant: Illinois will receive \$14.9 million in competitive federal grant funding from the US Department of Transportation's FY22-FY23 Charging and Fueling Infrastructure Discretionary Grant Program. The Illinois Finance Authority, in its role as the Illinois Climate Bank, was chosen to receive the funding to help expand electric vehicle (EV) charging infrastructure in the state.

Of the total \$18.7M project investment: 43% will be allocated for disadvantaged community projects while 63% will go to dense urban communities with a high percentage of multi-family housing, as well as rural communities and small towns. Read more here.

OTHER NEWS:

Assault Weapons Ban: The US Supreme Court denied Republican State Representative Dan Caulkin's request to review the Illinois Supreme Court ruling in his case surrounding the validity of Illinois' recently enacted assault weapons ban. The Illinois Supreme Court ruled previously that the gun ban does not violate the state constitution's equal protection clause by creating exemptions for certain trained professionals (such as retired police officers, and for people who owned the now-banned firearms). COGFA Report: The Commission on Government Forecasting and Accountability issued its December report. Concerning revenues, the Commission reports that "Illinois' General Funds receipts rose \$383 million in December as compared to the same month the prior year. While the performances of the individual revenue lines were mixed, growth in personal income tax receipts, with the help of revenue redistributions and a one-time transfer, has capped off an overall positive first half of revenues for FY 2024." Chicago Migrant Update: A new State-supported shelter began serving migrants in Chicago on Wednesday. Located in a former CVS in the Little Village neighborhood, the shelter is part of the city's existing asylum seeker shelter system and will house approximately 220 people as they transition to independent living.

Subject: Clarification of By-Laws Pertaining to Executive Session Attendance by Other Means

Recommendation:

Clarify by-laws to prohibit attending an Executive Session by other means (video, telephone, etc.). Further recommend that Executive Sessions be held in the Administrative Conference Room or another pre-designated on-site room, physically removed from the regular meeting location. Those in attendance at the regular meeting may remain in the regular meeting room during the Executive Session.

Background:

As discussed during the October 24, 2023 Board of Trustees meeting, Connect Transit

Administration has two sets of signed and notarized by-laws dated May 2015 and September 2015.

The May 2015 by-laws indicate that Trustees cannot attend a closed meeting by other means. In our meeting RSVP request to Trustees, we also included a phrase stating that 'Other means' is by video or audio conference. A Trustee(s) may not attend a closed meeting by other means....

Another set of by-laws dated September 2015 did not have this language included.

Each of the by-laws indicate that it was "approved unanimously by the Trustees at a meeting held on the 26th Day of May 2015 and are still in full force and effect."

Given the difference between by-laws, a concern that was raised, and the inconsistent information provided to the Board, Administration makes the recommendations shown above.

For reference, the Illinois Open Meetings Act (OMA) offers the following:

"Except as otherwise provided in this Act, a quorum of members of a public body... must be physically present at the location of a closed meeting. Other members who are not physically present at a closed meeting of such a public body may participate in the meeting by means of a video or audio conference..."

Clarification of by-laws November 26, 2023 Page 2 of 2

Discussion:

The OMA defines a "meeting" as "any gathering, whether in person or by video or audio conference, telephone call, electronic means (such as, without limitation, electronic mail, electronic chat, and instant messaging), or other means of contemporaneous interactive communication, of a majority of a quorum of the members of a public body held for the purpose of discussing public business..."

A closed meeting is allowed for specific purposes, including:

- Employment Matters
- Real Estate Matters
- Sale or Purchase of Securities
- Security Matters
- Litigation or Claims
- Informants

- Professional Ethics
- Peer Review
- Auditing Matters
- Closed Meeting Minutes
- A few others that don't pertain to the business of this Board.

Closed meetings are allowed because these are sensitive topics that impact the privacy and security of people or the agency. The question of whether to allow attendance by other means directly concerns whether the location of the "other means" is private and secure, and not open to others listening in and hearing the sensitive business of the Board.
